6. PRESIDENT'S REPORT

As the year draws to a close, I am honoured to present my first annual report as President of Stormwater Victoria. This past year has been marked by significant milestones for our association as well as our industry as a whole. Stormwater Victoria has achieved a great deal with collaboration and our growing partnerships in policy development, and community engagement, underlining our commitment to enhancing stormwater management across the state.

Our vigilant Policy and Advocacy subcommittee has been working on deepening our partnership with critical bodies like Melbourne Water (MW) working closely with them and other associations on the Urban Planning and Development Strategic Coordination Group (UPDSCG). In this space we have supported MW in improving processes, updating and refining guidelines, and creating future resilience in surface water and flooding. We have continued to work with the Association of Land Development Engineers (ALDE), supporting the land development space in surface water management. We have also had opportunities to seed new relationships, key to the advancement of our association. These have included discussions with the Institute of Public Works Engineering Australia (IPWEA), Urban Development Institute Australia (UDIA) and connections to the Victorian Water Minister, to name a few - all critical for our strategic objectives. In discussions with the new president of the Flood Management Association (FMA), we are exploring various collaborative possibilities that promise to enhance both our organisations' impacts on flood and stormwater management.



On a national scale, we have initiated a working group between states and the Stormwater Industry Association (SIA) to address common challenges and strategies. Our involvement in this group is set to improve collaborations across the state and provide Stormwater Victoria a greater influence in the activities and strategic direction of the national body as well as moving towards a national approach to knowledge sharing of stormwater management. Furthermore, the Stormwater Quality Improvement Device Evaluation Protocol (SQIDEP) working group, managed out of SIA is set to commence soon and is anticipated to further our efforts to develop a robust, fair and technically sound process for on sustainable urban water quality practices.

Our policy development initiatives have been robust. In the always highly anticipated VUDM news, we have secured funding from the Department of Energy, Environment and Climate Action (DEECA) who have enabled us to develop a robust governance arrangement for the development and management of the document, as well as distribute the first of many EOIs seeking industry input into the development of the document. Thanks to the support from DEECA, we are also due to host the entire VUDM process on a dedicated website, which will be live in the coming months. This will mean a greater involvement and input from our membership and our broader industry to help shape this document into something that will truly support the stormwater space to be the best it can be. Additional funding discussions are ongoing, ensuring that the VUDM maintains momentum and that it is an overall success.

Our communication and membership engagement strategy have been successfully growing, with our LinkedIn presence and our improved newsletter "The Outlet", managed by our committed Technical Events subcommittee. This consistent communication keeps our community well-informed and engaged with our activities and progress. Our Technical Events team have also been delivering highly sought after events both online and in person, bringing our membership the latest industry updates, explaining new industry trends and providing a platform for feedback and industry networking.

This year's conference in San Remo was a highlight, attracting over 250 delegates and reaching full capacity for the first time, reflecting the growing relevance and impact of our organisation. The event's success, coupled with the novel and well received social events, sets a high standard as we begin planning for the 2025 conference. The Conference Committee truly deserves a big shout out for what they have achieved this year, but they have their work cut out for them for the next one!

Reflecting on the year, I am so proud of our committee, the achievements and the strides they have made in positioning Stormwater Victoria as the leading body in sustainable and effective stormwater management. I am grateful for the support and dedication of all our members, partners, and stakeholders. Together, we have laid a strong foundation for future innovations and successes, driving our mission forward.

And now for an important message to our small and humble, but ever so important little stormwater industry. As we look ahead to 2025 and beyond, I wanted to take a moment to reflect on the extraordinary attributes that define our industry.
