Have your say: Flood Mitigation Inquiry

Is a Stormwater Levy required?

With the enormous interests and efforts over the years, in creating the best Integrated Stormwater strategies for the state, is it legitimate to ask what funding models are best able to ensure that the right projects can be delivered and maintained in providing liveability outcomes for the communities they serve.

The recent change of government in Victoria and the refreshing policy context that the Living Victoria roadmap process has the potential to deliver has sparked a little review of past history.

In 1999, with an understandable desire to set a new range of policy directions, the Bracks Labour Government announced its \$22.5 million Victorian Stormwater Action Program (VSAP) under its Greening Victoria policy, with a key aim of protecting water quality in Port Phillip Bay. The CSIRO Best Practice Guidelines were published at around the same time and were the product of research into stormwater management over the preceding years. Broadly, the VSAP model involved municipalities developing approved Stormwater Management Plans which would then be eligible for partnership funding and the program was supported by a number of capacity and knowledge building activities (eg Clearwater).

Funding under VSAP ran for a three year period (although project implementation continued for several years afterward) and in total \$50 million worth of stormwater investment was made across 273 projects. It is unclear why VSAP was discontinued, but perhaps one of the issues was very nature of the funding model which led to uncertainties around cost escalations and ongoing liabilities for maintenance. Certainly these are still questions which lurk around the traps when stormwater is mentioned in some circles.

10 years later, and we have continuous research efforts into various aspects of stormwater and integrated water management, one of the worst droughts in south eastern Australia's history, and a largely unpopular decision to construct Australia's largest desalination plant and a north-south pipeline.



While there has been growing interest amongst the broader water industry in Integrated Water Management and considerable federal government interest in developing localised water solutions, there still seems to be lacking a fundamental, ongoing and sustained funding mechanism that allows the range of necessary players to participate in an optimal manner.

The Ballieu government has provided the Living Victoria process, which provides promising outcomes for stormwater management for marine ecosystem protection a whole host of liveability benefits ranging from flood mitigation, resource efficiency, and place making. But is this sustainable?

In NSW, the state government legislated to allow Councils to voluntarily include a stormwater levy as part of the funds they could collect from their rate-payers and set out some principles to guide the expenditure of revenue collected. The stormwater levy provides a ongoing source of funds that can be used to develop projects, supply capital for implementation and ensure that maintenance activities can be carried out.

It is a legitimate question to ask of the MAC process, the broader stormwater industry and the range of supporting associations and institutions that will be needed to deliver a Living Victoria, what funding models are best able to do justice to past lessons learnt and ensure that the right projects can be delivered and maintained to deliver Liveability outcomes for the communities they serve.

Stormwater Victoria Study tour scholarship

Stormwater Victoria is pleased to announce a \$5000 sponsorship to contribute towards participation in the 2011-12 Water Sensitive Cities study tour being organised by Melbourne Water.

The Parliament of Victoria has launched an inquiry into flood mitigation infrastructure in Victoria with the recent widespread flooding that has occurred.

The Environment and Natural Resources Committed has invited SV to make a submission as we are viewed as a key stakeholder in stormwater management.

The terms of reference particularly relate to best practices and emerging technologies for flood mitigation; management of levees and waterways management.

SV has already approached The Minister for Water and DSE in relation to the Floodwise program used by Brisbane City Council. Although this system has suffered a little from network issues, the program has proved to be quite effective from a cost and function perspective.

Submissions are due by 5th August so we would need to coordinate a response by 29th July, in order to compile into the one submission.
